Thinking of making a donation to a charitable cause before the end of the year? This is a good time to do it, as the pandemic rages again... Under the CARES Act, part of the federal government's pandemic relief program that passed in March, individual taxpayers can take a deduction of up to \$300 for cash

donations made in 2020 when they file their tax return in the spring."
